SWCD granted \$125k to complete a water quality study of the Upper East Fork of the Whitewater River

Public Invited to Shape the Future of the Upper East Fork Whitewater River Watershed

The Wayne County SWCD is leading efforts to develop a watershed management plan for the Upper East Fork Whitewater River Watershed. This plan will address natural resource concerns in the basin and set goals to protect and improve water quality. Individuals who live, work, farm, or play in the East Fork Whitewater River Basin are invited to share their valuable input

This initial stage of the project aims to gather data and information, develop the project steering committee, and begin formulating the gathering of public opinion. Your perspectives on the Whitewater River, its lakes, streams, and watershed are crucial. The Upper East Fork Whitewater River Watershed project is in its early stages, with planning efforts just beginning in the community. Getting involved in a watershed project offers a direct opportunity to contribute to the health and sustainability of the local water resources that impact your community, from drinking water and recreation to the natural environment.

Over the next year, water sampling of creeks in the watershed will occur twice monthly through October. Sampling will swap to every other month through the winter and conclude with biweekly sampling again in the spring. The analysis of the data collected will help pinpoint those areas of concern and help establish goals for the watershed. Over the next two years, the watershed management plan will be developed. The development of this plan will allow those living and working in the watershed to request funds to help implement the plan and meet plan goals in the future.

In addition to water sample analysis and plan development, it is also beneficial to hear from a multitude and a variety of stakeholders in the watershed to best understand the natural resource concerns. If you were to list the top ten natural resource concerns around you, what would they be? Some might list soil erosion, river access or algae blooms. Others might say lack of wildlife habitat, still others may say too many non-native invasives. If you'd like to share your thoughts and suggestions regarding water quality, quantity, stream and lake quality, recreation, or other related topics; receive copies of water chemistry data results; **join an event or upcoming meeting, please reach out to Sara Peel, Watershed Coordinator at speel@arionconsultants.com.**
